Whereas: the Lake Merced Task Force strives to enhance community wide appreciation for the Lake Merced Watershed, and

Whereas the Lake Merced Task Force seeks local involvement in enhancing community wide access to the Lake Merced watershed, and

Whereas John K. Melvin, an artist in San Francisco, has presented a concept for the temporary installation of a piece of art at the Lake Merced Watershed, and

Whereas prior to the installation of this artwork all environmental considerations will have been fully vetted and all necessary permits obtained, and
